Once the membership secretary has received your application it can take up to 3 weeks for it to be processed. If you have provided an email address you will received an email confirming that your application has been processed together with further details about the membership benefits of the KVRC. Please note you are not covered by BRC insurance at riding club events until your membership has processed.

Please ensure you write your email address clearly and correctly as the membership secretary does not have time to chase incorrect email addresses and ring round if email addresses are not supplied. You may miss out on receiving information quickly if your email address is not supplied as you will have to wait for the information to be published in the newsletter or on the website (www.kvrc.co.uk).

Once the membership card templates are received from British Riding Clubs you will be sent your membership card. These are normally sent out once a month however there is a delay in the winter as the new season's cards are not received until BRC have produced them which usually does not happen until January or February.

Should you need your membership card in the meantime please email the membership secretary and she will try to contact which ever organisation you need to show it to and confirm that you are a member. Please try to give her a week's notice.

CHEQUES TO BE MADE PAYABLE TO THE KENNET VALE RIDING CLUB.

As you will appreciate, health and safety is becoming an area of concern for volunteer organisations. We are an affiliated riding club with the British Riding Clubs (BRC) to which we pay a fee for each member we have. They provide us with insurance cover for our events and training sessions. However we ask that you take heed of the following warnings before attending any events or training sessions:

- Hard hats to PAS015 or EN1384 must be worn, with chin straps fastened, at all times when mounted at all events/training sessions. Back protectors are advisory at all mounted events and are mandatory for cross country competitions/schooling.
- Horses are easily frightened and can be dangerous. Please support us in ensuring members of the public are requested to keep clear from the horse areas and to avoid behaviour which might alarm horses.
- Save for the death or personal injury caused by the negligence of KVRC or anyone for whom they are in law responsible, the organisers accept no liability for any loss or damage, accident, injury or illness to horses, owners, riders, spectators, vehicles or any property or persons howsoever arising at a KCRC event.
- KVRC will take all reasonable precautions to ensure the health and safety of everyone present. For these measures to be effective everyone must take responsibility for the behaviour of their own horses and must take reasonable precautions to avoid and prevent accidents occurring and must obey the instructions of the organisers and officials.
- At training sessions, you are responsible for advising the trainer of you and your horse's ability and informing the trainer if you feel you feel that the session is getting to a level beyond your ability to perform safely.
- Children under 16 years of age must be supervised by a responsible adult at all KVRC events/ training sessions.
- Dogs must be kept on leads under close control.
